Good, then you're ready to make a WHISTLEBLOWING REPORT!

This guide will provide you with concrete instruction on how to use the dedicated platform!

FOREWORD

The company has chosen a platform (Trusty) that complies with the safety and confidentiality requirements provided for by the legislation!

THE HOME-PAGE

On the home page you will find a description of the service, the button to start the report, "Fare un rapporto" (Make a report), the button to check the status of the report (after you have sent it) "La tua casella di posta" (Your inbox), the Frequently Asked Questions, informative links on the platform.


STEP 5: REPORT CODES

At the end of the report, the platform will assign you a username and password, through which you can access the control panel of your report (called "La tua casella di posta" (Your inbox).

Through "La tua casella di posta" (Your inbox), you can: follow the evolution of the report and the feedback provided by the Data Controller; provide any additional elements that you deem useful.

To access the dashboard of your report:

Click on "La tua casella di posta" (Your inbox) in the platform homepage, and enter the codes.



FINAL NOTES (summary of the contents of the legal notices and privacy policy):

Remember that REPORTING AN ILLEGAL ACTIVITY is an act of **manifestation of civic sense**, through which you can contribute to the emergence and prevention of risks and situations prejudicial to the collective public interest and for the company.

Your identity will therefore be **protected** in any context and **no form of retaliation** or **discriminatory measure**, direct or indirect, affecting working conditions for reasons related to the report shall allowed or tolerated.

However, we remind you that, in the event of a slanderous or defamatory report, you could be required to respond in **criminal and disciplinary proceedings**. No manifestly opportunistic reports are allowed and/or made for the sole purpose of damaging the defendant or other individuals and any other hypothesis of improper use or intentional instrumentalization of the service. No reports can be made concerning complaints/grievances of a personal nature.

Stick to the facts, reporting only UNLAWFUL INCIDENTS of which you have reasonable assurance of truthfulness! Try to be precise and detailed in the description, while avoiding entering irrelevant data.
